## ❖ Cubic Yard Totes

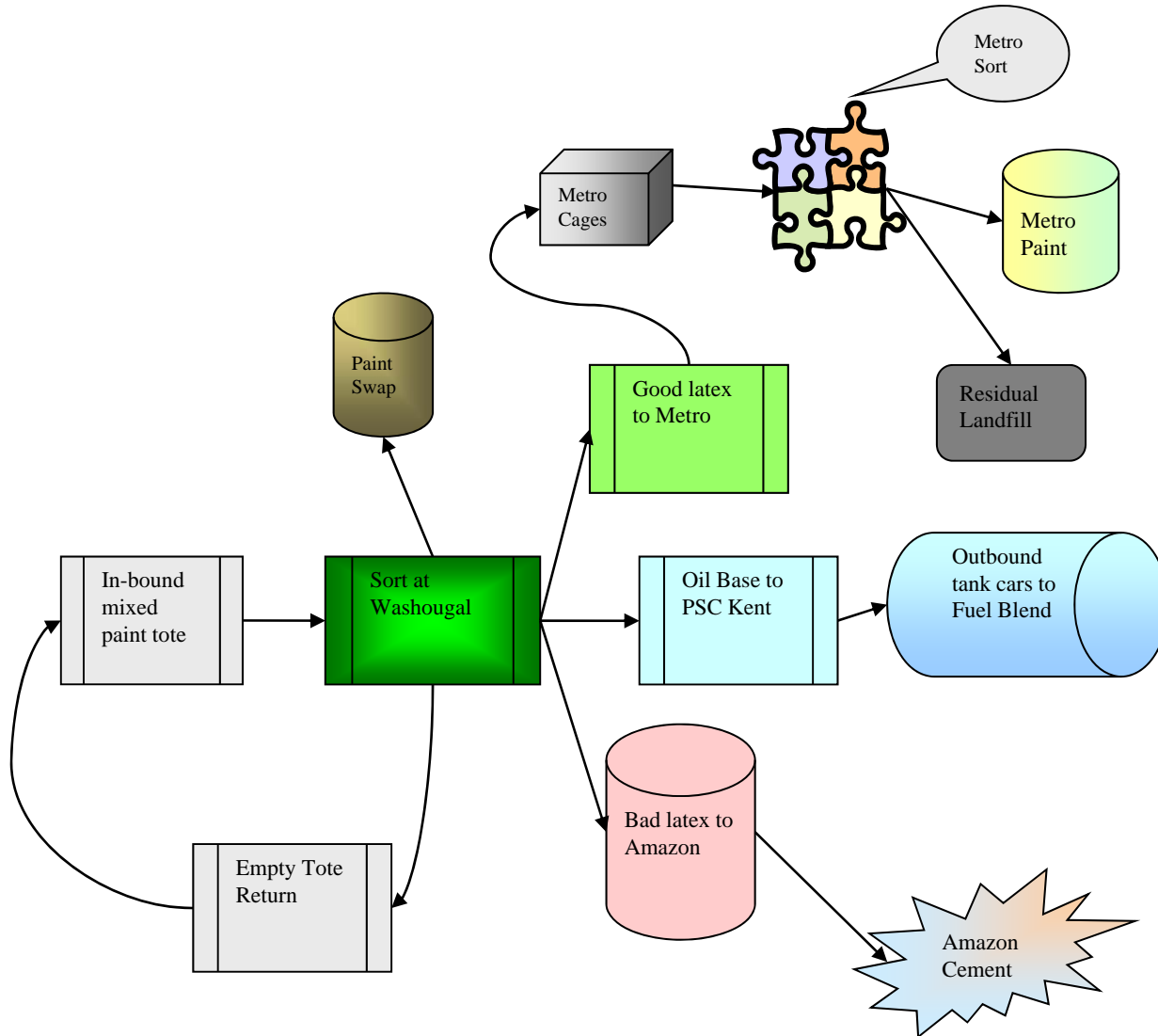


- ❖ Floor Space Requirements (48" x 44")
- ❖ Stackable, Built-in Containment
- ❖ Store in covered area on solid surface

- ❖ **PSC to provide all shipping documents**
- **Oil and Latex co-mingled in bins**
- **DOT SP-11624, Flammable Sticker, DOT Label, Up Arrows, Sequential bin numbers**
- **Bill of Lading**

- All collection sites will be provided the same service level
- Collection to be done by contractor or County personnel – labeling and transportation by PSC.
- Collection containers for HHW event to be determined - could be totes, roll-off bins or combination of both

- Burlington Environmental (PSC) is transporter
- Envision a combination of 24' and 48' vans to service the state
- Will likely have electric pallet jacks.
